## **Foundational Concepts**

### **Authorized Shares**

The maximum number of shares a company is legally permitted to issue. This includes all outstanding shares, those held by insiders, and any that could potentially be issued in the future.

### **Float Shares**

The portion of a company's total shares that are available for public trading. This excludes restricted shares held by company insiders.

### **Face Value**

Also known as par value or nominal value, this is the stated value of a share as recorded in the company's books. It's important to note that face value often bears little relation to the actual market price of a share.

## **Market Sentiment**

### **Bear**

An investor who believes that the market or a particular security will decline in value. In a broader sense, a "bear market" refers to a prolonged period of price declines, typically 20% or more from recent highs.

### **Bull**

The opposite of a bear, a bull is an investor who expects the market or a specific security to rise in value. A "bull market" indicates a period of sustained price increases.

## **Trading Basics**

### **Ask Price**

The lowest price at which a seller is willing to part with their shares. It's essentially the "offer" price in the market.

### **Bid Price**

Conversely, this is the highest price a buyer is prepared to pay for shares. The difference between the ask and bid prices is known as the spread.
