

ASSETS



Assets are resources owned by a company that have economic value. They are the result of investments made by the company or its owners. Assets are classified into two main categories: **Current Assets** and **Non-Current Assets**.

Current Assets are those that can be converted into cash within a short period, typically less than one year. Examples include cash, accounts receivable, inventory, and prepaid expenses.

Non-Current Assets are those that are not expected to be converted into cash within a short period. Examples include property, plant, and equipment, intangible assets, and investments.

The accounting equation states that **Assets = Liabilities + Equity**. This means that the total value of a company's assets must always equal the sum of its liabilities and equity.

LIABILITIES



Liabilities are obligations or debts that a company owes to external parties. They are the result of borrowing money or purchasing goods and services on credit. Liabilities are classified into two main categories: **Current Liabilities** and **Non-Current Liabilities**.

Current Liabilities are those that are due within a short period, typically less than one year. Examples include accounts payable, short-term debt, and accrued liabilities.

Non-Current Liabilities are those that are due after a period longer than one year. Examples include long-term debt, deferred tax liabilities, and pension liabilities.

The accounting equation states that **Assets = Liabilities + Equity**. This means that the total value of a company's liabilities must always equal the total value of its assets minus its equity.

CONTRIBUTED CAPITAL

Contributed Capital represents the amount of capital that has been provided by the company's owners. It is also known as **paid-in capital** or **equity capital**. Contributed capital is divided into two main categories: **Common Stock** and **Preferred Stock**.

Common Stock represents the ownership interest of common shareholders. It is the most basic form of equity and typically has no voting rights.

Preferred Stock represents the ownership interest of preferred shareholders. It typically has a fixed dividend rate and priority over common stock in the event of liquidation.

RETAINED EARNINGS

Retained Earnings represent the portion of a company's net income that is retained within the company rather than distributed to shareholders as dividends. Retained earnings are used for a variety of purposes, including reinvesting in the company, paying off debt, and funding research and development.

The accounting equation states that **Assets = Liabilities + Equity**. This means that the total value of a company's retained earnings must always equal the total value of its assets minus its liabilities and contributed capital.

EQUITY



Equity represents the ownership interest in a company. It is the sum of all assets minus all liabilities. Equity is divided into two main categories: **Contributed Capital** and **Retained Earnings**.

Contributed Capital represents the amount of capital that has been provided by the company's owners. It is also known as **paid-in capital** or **equity capital**.

Retained Earnings represent the portion of a company's net income that is retained within the company rather than distributed to shareholders as dividends.
