

Credit Dispute Letter Template for Disputing Credit Report Errors

The following is a sample credit dispute letter you can use to dispute errors in your credit report. Note that this is just an example to help you get an idea of what a dispute letter should look like.

When listing the items you want to dispute, make sure that you describe it as best as you can. If the credit bureaus find your dispute as frivolous, they are not required to carry out an investigation.
