**MOTION FOR CONTINUANCE**

Pursuant to 8 CFR 1003.29 and Section 5.10 of the Immigration Court Practice Manual, Respondent, by and through undersigned counsel, respectfully requests that this honorable Court grant a continuance of his Individual Calendar Hearing scheduled for DATE AND TIME. In support of this request, Respondent states the following:

1. Respondent's Motion to Substitute Counsel was granted by this Court on or about DATE. Attorney NAME, the undersigned counsel, is now representing Respondent on a *pro bono* basis through the National Immigrant Justice Center (NIJC) *pro bono* attorney program.
2. At Respondent's last Master Calendar Hearing on DATE, NAME filed Form I-589, Application for Asylum and Withholding of Removal, on behalf of Respondent. On the same day, the Individual Calendar Hearing was scheduled for DATE AND TIME, so that Respondent and NAME had sufficient time to fully prepare and present his claim for asylum.
3. On DATE, this Court issued a new Notice of Hearing, indicating that Respondent's Individual Calendar Hearing was now scheduled for DATE AND TIME. This Motion for Continuance was prepared and filed as soon as practicable upon receipt of the new Notice of Hearing on DATE.
4. Copies of the Notices of Hearing dated DATE and DATE, respectively, are attached to this Motion for Continuance.
5. Respondent is currently in the custody of the Department of Homeland Security, and is detained at JAIL. Communication with individuals detained at this facility is restricted to particular times during the day.
