He was chosen ten times by the Ius Software Poll as one of the Ten Most Influential Slovenian Lawyers and won the 2001 Lawyer of the Year Award granted by the Slovenian Federation of Lawyers' Associations. In 2002, he was the Slovenian candidate for a judge at ITLOS. He participated in drafting most of the Slovenian transport and insurance legislation after its independence. Prof. Payliha was also a longstanding President of the Maritime Law Association of Slovenia. He is author and co-author of 23 books and over 500 articles and scientific papers. He lives with his wife and two children in a small village Nova vas nearby the Slovenian Adriatic coast.
