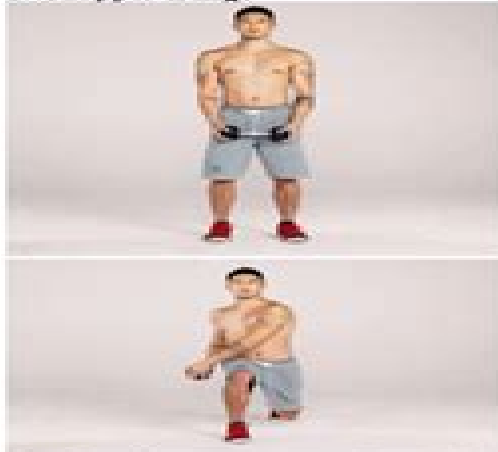


1. Chopper Lunge



Benefits: Not only are you developing your quads and glutes with this move, you're also stretching and extending the hip flexors and challenging your core as you swing your arms to each side. Stand with your feet shoulder-width apart, feet parallel, holding a dumbbell (or a sandbag), with both hands in front of your chest. This is the starting position. Step your right leg backward into a lunge, simultaneously lowering your right knee until it's close to (but not touching) the ground and lowering the weight to the outside of your left (forward) thigh as if paddling a canoe. Return to the starting position and repeat, this time stepping back with your left leg and lowering the weight to the outside of your right thigh. Continue alternating legs.

2. Single Leg Squat Jump



Benefits: Another move that tests your balance, the single leg squat jump works your quads and glutes, while also improving your explosive strength. Stand and lift your right foot a few inches off the floor, so it rests by your left ankle. Keeping your right foot elevated, dip your left knee and swing your arms behind you, as if prepping for a jump. Swing your arms forward and up, exploding off the floor with your left foot. Land softly on your left foot, keeping your right foot elevated, and repeat. Do equal reps or time on both sides.
