#### WHAT IS A TORT?

- Defined as a civil wrong, a tort is distinguished from contract, restitution and equilibries wrongs.
- This card covers the major torts of megigence, wrongful death, breach of statutory duty, trespose and intentional torts, defamation and nulsance.

#### ACTIONS IN TRESPASS V ACTIONS ON THE CASE

 There are many areas of tort action, including actions in trespass and actions on the case.

#### DOES THE CLAAPPLY?

- The first question to be asked in any torts case is, does the CLA apply? This is a matter of statutory interpretation.
- The CLA legislation is focused generally on negligence as a mode of action rather than necessarily as a cause of action, regardless of whether the claim is brought in tort, in contract, or under atsuze. Equivalent provisions exist in most other jurisdictions, atheographies is variation.
- Scope of CLA varies. In NSW and Tas multiers arising because of an intention to harm or in cases of sexual assault are excluded. The other jurisdictions do not all have an equivalent provision. WA CLA s 3A is more restrictive. In regard to personal injury the Old CLA excludes workers compensation among other matters.

#### MEGLIGENCE

- Negligence is a common law tort that is an action on the case. Damage therefore must be proved.
- Elements of the tort required to establish a cause of action:
  - duty owed by D to P;
  - duty breached by D;
  - breach causing damage to P (where the damage is not too remote from the breach).

#### DUTY

- Dowers a duty to P if it is reasonably forescentile (see below) that if O carries out the act or omission contemplated, a person in P's postion could be harmed (neighbour principle) Domoghae v Savernace (1992) 1 AC 5623. This is enough to establish duty for personal injury or property damage caused by an act.
- For other categories reasonable foreseasability as above AND salient factors according to the category must be established: Sullivian v Alcody (2001) 207 CLR 562: Catley Refinence (Clot Pty Lid v Staver (2000) 75 NSWLR 649.
- Salient factors can include willnerability to harm, type of harm, and the control a party has over another. As well, salient factors can emerge from public policy issues, eg. indeterminate liability according to the category of case.
- It is not recessary for the precise chain of events to be forescenable, merely that the final outcome (in: damage or injury) is reasonably forespecially. Chapman v Huarse (1961) 105 CLR 112: Paragraf v Long Infand Railroad Co 245 NY 339 (1928) (US).

#### Pure economic loss
