Iran's Petroleum Exports to China and U.S. Sanctions

Some Members of Congress remain concerned with the ability of longtime U.S. adversary fran to raise revenue by selling petroleum. The United States has sought to reduce other countries' imports of Iranian petroleum via sanctions, including some new sanctions authorities enacted in the 118th Congress. Since 2021, nearly all Iranian petroleum exports reportedly have gone to the People's Republic of China (PRC, or China), with traders using a range of evasive techniques. Citing the threat of Iran's nuclear and ballistic missale programs and its support for terrorist groups. President Trump in February 2025 directed the imposition of "maximum pressure" on Iran, including a campaign to drive Iran's oil exports to "zero."


Background: U.S. Sanctions

U.S. efforts to limit Iranian income from crude oil, petroleum products, and petrochemical products (petroleum) via sanctions go back decades. Section 1245(d) of the FY 2012 National Defense A withorization Act (NDAA, P.L. 112-81; 22 U.S.C. 18513a(d)) directs the President to block from the U.S. financial system foreign financial institutions that knowingly conduct "any significant financial transaction" with sanctioned Iranian banks, including Iran's Central Bank, excluding foreign central banks that do not engage in transactions related to Iranian petroleum. The statute also authorizes the President to except from secondary sanctions foreign financial institutions in countries determined to be significantly reducing their purchases of Iranian crude oil (President Trump approved the last such exception in 2018).

In 2018, President Trump ceased U.S. participation in the Joint Comprehensive Plan of Action (JCPOA) and issued Executive Order (E.O.) 13846, which reinstated sanctions that had been terminated pursuant to the JCPOA, including on the "purchase, acquisition, sale, transport, or marketing" of Iranian petroleum. In January 2020, President Trump issued E.O. 13902, authorizing the imposition of sanctions on those operating in or engaged in the "sale, supply, or transfer to or from Iran" of goods or services related to specified sectors of the Iranian economy; in October 2024. then-Treasury Secretary Janet Yellen issued a determination, authorizing those sanctions under E.O. 13902 to apply to fran's petroleum sector. Under these executive orders, the United States has sanctioned dozens of entities for their rule in the shipment of Iranian petroleum to Asia.

Iran's Petroleum Exports to the PRC

U.S. secondary sanctions aim to deny revenue to the primary target by imposing costs to dissuade foreign persons from participating in activities that are illegal for U.S. persons. Iranian petroleum exports reportedly hit a record in the first quarter of 2024, with "almost all" going to China, and remain high as of early 2025 despite some reported disruptions. The U.S. Energy Information Administration (EIA) estimated in an October 2024 congressionally mandated report that Iranian petroleum sales generated revenues of \$53 billion in 2023 and \$54 billion in 2022. China's continuing imports of Iranian petroleum may demonstrate that PRC-based buyers believe that the economic benefits of buying Iranian petroleum exceed the risks of U.S. sanctions.

coupled with the cut off of Iran from the international banking system caused a sharp drop in the value of Iran s currency the rial raised inflation to over 50% and reduced Iran s accumulation of and access to reserves of foreign exchange Iran s economy shrank by about 5% in 2013 and many Iranian firms shut down or reduced operations Prior to agreeing to the JPA Iran's main strategy for trying to mitigate the effects of sanctions included creating front companies and using barter trade and informal banking exchange mechanisms Iran also increased non oil exports or exports of hydrocarbon products other than crude oil such as petrochemicals and gas condensates Affluent Iranians have been investing in and driven up prices for real estate and securities listed on the Tehran stock exchange Sanctions also attempted to directly slow Iran s nuclear and missile programs and reduce its military power by hampering its acquisition of foreign technology and weaponry U S assessments indicate mixed success in these efforts although Iran is not believed to be acquiring new advanced conventional weaponry Based largely on its provision of arms to the Assad government in Syria Iran is not complying with U N requirements that it halt weapons shipments Sanctions have not altered Iran's repression of dissent or monitoring of the Iran Kenneth Katzman, 2008 The Bush Administration has pursued several avenues to attempt to contain or end the potential threat posed by Iran at times pursuing limited engagement and at other times leaning toward pursuing efforts to change Iran's regime Some experts believe a potential crisis is looming over Iran's nuclear program because the Bush Administration is sceptical that efforts by several European allies to prevent a nuclear breakout by Iran will succeed although the Administration announced steps in March 2005 to support those talks U S concerns have been heightened by the victory of Mahmoud Ahmadinejad an admitted hardliner in Iran's presidential election on June 24 2005 Some advocate military action against Iran's nuclear infrastructure but others believe that a combination of diplomatic and economic rewards and punishment are the only viable options on the nuclear issue U S sanctions currently in effect ban or strictly limit U S trade aid and investment in Iran and penalise foreign firms that invest in Iran s energy sector but unilateral U S sanctions do not appear to have materially slowed Iran s WMD programs to date Other major U S concerns include Iran s policy in the Near East region particularly Iran s material support to groups that use violence against the U S led Middle East peace process including Hizballah in Lebanon and the Palestinian groups Hamas and Palestinian Islamic Jihad Some senior Al Qaeda activists are in Iran as well although Iran claims they are in custody and will be tried Iran did not obstruct the U S effort to oust Iraq's Saddam Hussein a long time Tehran adversary at least partly in the expectation that pro Iranian Shiite Islamic factions would come to power in Iraq in the aftermath That result occurred as a product of 30 January 2005 elections there Iran is also assisting pro Iranian local leaders in Afghanistan although that support does not appear to be materially hindering the stabilisation and development of Afghanistan Iran s human rights practices and strict limits on democracy have been consistently criticised by official U S and U N reports particularly for Iran s suppression of political dissidents and religious and ethnic minorities New limits on personal freedoms could be imposed by Ahmadinejad who has consistently
