- Extend price guarantees as agreed upon by both parties. Price guarantees are usually extended for non-volatile products, examples of which include non-paper office supplies, non-petrochemical-based products as well as non-agriculturalbased products.
- Extend credit terms of 45 days and credit line of P100,000 per month.
