Mexico June S Beittel, 2019-08-22 Mexican drug trafficking organizations DTOs pose the greatest crime threat to the United States and have the greatest drug trafficking influence according to the annual U S Drug Enforcement Administration s DEA s National Drug Threat Assessment These organizations work across the Western Hemisphere and globally They are involved in extensive money laundering bribery gun trafficking and corruption while causing Mexico s homicide rates to spike They produce and traffic illicit drugs into the United States including heroin methamphetamine marijuana and powerful synthetic opioids such as fentanyl and they traffic South American cocaine As Mexico s transnational crime groups expanded their control of the opioids market U S overdoses rose sharply to a record level in 2017 with more than half of the 72 000 overdose deaths 47 000 involving opioids Although preliminary 2018 data indicate a slight decline in overdose deaths many analysts believe trafficking continues to evolve toward opioids making possible a future rise of overdose deaths from opioids This prospect deeply concerns Congress In July 2019 the notorious crime boss Joaquin Guzm n Loera El Chapo received a life sentence in a maximum security U S prison for his role leading the Sinaloa Cartel Guzm n had been extradited by Mexico to the United States in January 2017 following two escapes from Mexican prisons The major Mexican DTOs while increasing their business in opioid supply have continued to diversify into such crimes as human smuggling and oil theft According to the Mexican government s latest estimates illegally siphoned oil from Mexico s state owned oil company costs the government about 3 billion annually Mexico s DTOs have been in constant flux Former Mexican President Felipe Calder n 2006-2012 launched an aggressive campaign against the country s drug traffickers that was a defining policy of his government the DTOs violently resisted this campaign By some accounts there

were four dominant DTOs in 2006 the Tijuana Arellano Felix organization AFO the Sinaloa cartel the Ju rez Vicente Carrillo Fuentes organization CFO and the Gulf cartel Government operations to eliminate DTO leadership sparked organizational changes which increased instability among the groups and violence Over the past 12 years Mexico s large and comparatively more stable DTOs fragmented creating at first seven major groups and then nine which are briefly described in this report The DEA has identified those nine organizations as Sinaloa Los Zetas Tijuana AFO Ju rez CFO Beltr n Leyva Gulf La Familia Michoacana the Knights Templar and Cartel Jalisco New Generation CJNG Mexico s intentional homicide rate reached new records in 2017 and 2018 In 2019 Mexico s national public security system reported more than 17 000 homicides between January and June setting a new record For some Members of Congress this situation has increased concern about a policy of returning Central American migrants to cities across the border in Mexico to await their U S asylum hearings in areas with some of Mexico s highest homicide rates Mexican President Andr s Manuel L pez Obrador elected in a landslide in July 2018 heads a new party MORENA He campaigned on fighting corruption and finding new ways to combat crime including the drug trade He aimed to avoid the previous two administrations failure to lower violence and insecurity According to some analysts challenges for L pez Obrador since his inauguration include a persistently ad hoc approach to security absence of strategic and tactical intelligence concerning an increasingly fragmented multipolar and opaque criminal market and endemic corruption of Mexico s judicial and law enforcement systems

manufacturers or suppliers with the purpose of maintaining prices at a high level and restricting competition neither Department of Defense DoD nor Department of Homeland Security DHS have a published definition for cartel For purposes of this study it is important to note that the agglomeration of criminal organizations acting in concert can be considered a cartel When criminal organizations are dispersed and don t act in concert to control supply then the drug market can be said to be more competitive since a few dominant players are not able to fix prices More competitive markets are the problematic ones because smaller players might be tempted into taking risks on behalf of terrorist groups

The likelihood of cooperative relationships between Mexican drug cartels and Al Qaeda s core or the Islamic State of Iraq and Syria ISIS is a matter of debate and U S national security Despite the significance of the issue the topic is widely void of objective analysis When analyzed and compared the organizational attributes of strategy toward the United States group identity ideology and decision making authority show stark differences between these groups With these organizational attributes established and then placed in the context of what makes cooperative relationships work within the private sector cooperation between groups emerges as highly unlikely While the occurrence of a relationship between these groups is doubtful if it were to occur the implications to U S national security could be catastrophic As such this study concludes with a policy recommendation that the United States must continue to publicly monitor the potential relationships to deter them This study identifies conditions if any that could result in operational cooperation between Mexican drug cartels and Islamic transnational terrorist groups Historically some governmental organizations and the media have speculated on this topic because of oversimplified use of terminology and a lack of understanding of how such factors as organizational identity and intra group trust strategy ideology and organizational structure influence violent sub state groups decision making Admittedly a proven nexus between narcotics and terrorism does exist in some countries at some times however this does not imply a direct cooperative relationship between these organizations everywhere Narco terrorism has been argued to be both a means and an end which further confuses what narco terrorism is and where a nexus between the two exist
