With the ongoing expansion of outbound foreign direct investment (FDI) in the countries representing the BRICS economic bloc (Brazil, Russia, India, China and South Africa) and with all of them at the same time listed among the top seven countries plagued by tax evasion and avoidance in the guise of illicit outflows, the five governments both individually and through cooperative initiatives have devised new international tax strategies that are proving to be of great interest and value to other countries both developing and developed.
