SUBJECT: Notification of Debarment Action

1. On June 12, 2014, you entered Joint Base San Antonio-Lackland, Texas, without authorization to take photographs and make a broadcast. You did this after being specifically informed by the installation Public Affairs Office (PAO) that the facility you wished to film already had a media day, which you failed to attend. Furthermore, you were told that the PAO could only authorize your entrance if there was an approved and scheduled media event. The PAO specifically confirmed for you that the facility you wished to visit was not having a media event at that time and, therefore, entrance onto the installation was not authorized. Despite this information and direct instruction, you circumvented proper installation access procedures and gained unauthorized access to a secure military installation to engage in unauthorized photography and broadcast.

2. It has been determined that your actions are detrimental to the maintenance of good order and discipline, as well as to the safety and security of the installation. You are hereby put on notice that should you make unauthorized entry into any of the Joint Base San Antonio (JBSA) installations in the future, a debarment order will be issued and you will be prohibited from entering JBSA-Lackland, Randolph, Fort Sam Houston, Camp Bullis and all annexes and leaseback facilities from that point forward for a defined period of time. Should such a debarment order be promulgated, any entrance onto a JBSA installation, to include any of the aforementioned areas, will subject you to detention by security personnel for delivery to the appropriate civilian or military authorities.

3. If you fail to comply with a debarment order, you will be subject to prosecution under Title 18 of the U. S. Code, Section 1382, Entering Military, Naval or Coast Guard Property, which states: "Whoever, within the jurisdiction of the United States, goes upon any Military, Naval or Coast Guard reservation, post, fort, arsenal, yard, station or installation, for any purpose prohibited by law or lawful regulation; or, whoever reenters or is found within any such reservation, post, fort, arsenal, yard, station or installation after having been removed there from, or ordered not to reenter by any officer or person in command or charge thereof, shall be fined not more than [\$5,000.00] or imprisoned not more than six months, or both" [as amended by 18 U.S.C. § 3571(b)(6)].
