In a series of case studies Dyer reconstructs the constitutional arguments of prominent antislavery thinkers such as John Quincy Adams, John McLean, Abraham Lincoln, and Frederick Douglass who collectively sought to overcome the legacy of slavery by emphasizing the natural law foundations of American constitutionalism. What emerges is a convoluted understanding of American constitutional development that challenges traditional narratives of linear progress while highlighting the centrality of natural law to America's greatest constitutional crisis.

After the Revolution Justin Buckley Dyer, 2009 Public actors associated with the tradition of American antislavery constitutionalism in the nineteenth century insisted that the Constitution of 1787 contained certain inbuilt purposes or animating principles which ought to have aided constitutional interpreters in construing specific provisions of the constitutional text that related directly or indirectly to the law and politics of slavery in the United States. The Constitution of 1787 recognized the existence of slavery in the several states yet antislavery constitutionalists interpreted even the slavery-related clauses as aspiring toward a certain liberal constitutional vision that was not yet a reality. In this dissertation I argue first that these nineteenth-century interpretations of the Constitution in antislavery terms were intricately bound up with theories of natural law and second I suggest that this aspect of the antislavery constitutional tradition offers a strong interpretive challenge both descriptive and normative to various aspects of the current scholarly literature on constitutional development and constitutional theory.
