La France libre est le nom donné par le général Charles de Gaulle à l'organisation d'une Résistance extérieure après l'appel du 18 Juin. C'est à la fois une structure politique reconnue par les Alliés, une armée les FFL et des territoires. Les FFL (forces françaises libres) sont les forces armées (terrestres, navales, aériennes) de la France libre engagées contre l'Axe sous l'autorité du général De Gaulle. Ayant rejoint Londres en 1940, le général De Gaulle y crée la France libre, une organisation politique et militaire ayant pour but de reconquérir la France qui est occupée par l'Allemagne depuis juin 1940, en plus de l'occupation Nazis, l'arrivée du maréchal Pétain qui obtient les pleins pouvoir le 10 juillet 1940 n'arrange rien à la vie des français. Ainsi le général De Gaulle, avec l'appui de Winston Churchill, œuvre à unifier les résistances intérieures et à préparer l'avènement d'un nouveau régime après la guerre.

Nous sommes donc en mesure de nous demander comment se développe la France libre et quel est son rôle ?

Nous commencerons par étudier le leader, les effectifs et les territoires qui participent au mouvement France libre.

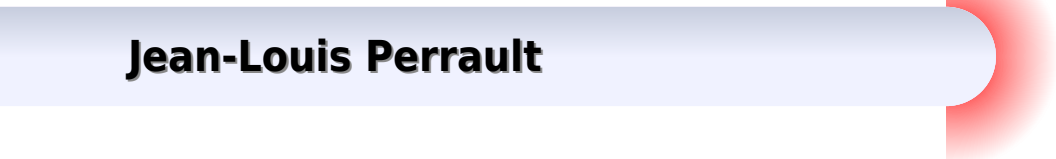
Puis nous analyserons les combats menés par la France.
