over non American Indians traveling on public roads through reservations In a pair of cases the Court reinforced the court made doctrine of qualified immunity In both cases the high court said the law was not so clearly established as to allow litigation against the officers to move forward In a civil rights case the court sent the case back to the circuit court to determine if the suit can move forward
