- At Respondent's last Master Calendar Hearing on DATE, NAME filed Form I-589, Application for Asylum and Withholding of Removal, on behalf of Respondent. On the same day, the Individual Calendar Hearing was scheduled for DATE AND TIME, so that Respondent and NAME had sufficient time to fully prepare and present his claim for asylum.
- On DATE, this Court issued a new Notice of Hearing, indicating that Respondent's Individual Calendar Hearing was now scheduled for DATE AND TIME. This Motion for Continuance was prepared and filed as soon as practicable upon receipt of the new Notice of Hearing on DATE.
