ABSENTEE BALLOT

Voters unable to vote in person on Election Day may be eligible to vote by absented ballot. Most absentire voters must appear before the Circuit Clerk or Municipal Clerk and absentee vote in person, it first collegiones of absentine votion may request a mailed bullet, Voters, who are required to be at work while the polling places are open on Election Day or will be out of town, must absentes vote in person. Absentes voters, who are 65 or older, have a permanent or temporary physical disability or are temporarily residing outside their county of residence may absentive yone by mail. Please sheck with your Circuit or Municipal Clark to determine if you are entitled to vote by an absentee ballot and to learn the procedures for doing so. If you know you will vote by an absenter ballot, you may visit or contact your Circuit or Municipal Clint's Office at any time within 45 days of the election.

Voters included within the Uniform and Overseas Citizens Abunitive Voting Act (UOCAIA), such as members of the military and overseas citizens, may register to vote and request an absentice ballot by Rederal Post Card Application (IPCA), UOCAIA voters may register to vote using the FPCA up until ten days before the date of an election and may receive and return an absentice ballot by mail, email, or fix.

Absentee ballots are now final votes. If you cant un absentee ballot, you may no longer cast a negular ballot on Election Day but you may cast an affidavit ballot. If you know you will vote by an absentee ballot, you may visit or contact your Circuit or Municipal Clerk's Office at any time within 45 days of the election.

VOTER REGISTRATION DEADLINES

To wote, you must register either in person, at the Circuit Clerk's Office, Municipal Clerk's Office, Municipal Clerk's Office, or at a Public Service Agency (like DPS), or by mail-in registration application at least 30 days prior to the date of the election. All applications must be postmarked on or before 30 days prior to the date of the election. If the 30th day falls on a Sunday or legal holiday, then both the postmark and in-person deadline is extended to the next regular business day.

Voters who have not yet reached the age of 18 at the time of a primary election may vote in the primary election so long as he/she will reach the age of 18 on before the date of the general election.
