As part of its mandate to drive service innovations in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), the Bangsamoro Government, through the Ministry of the Interior and Local Government (MILG), has partnered with United Nations Development Program (UNDP) Philippines to launch the Localizing e-Governance for Accelerated Provision of Services (LeAPS) Program.

The #DigitalBangsamoro Web Portal will provide digitized citizen-centric public services of the various local government units (LGUs) and ministries in the BARMM. These e-Services will be made available through single access points while transforming into less paper offices built upon simplified information and service platforms. The portal will serve as the lighthouse for the service-seekers among Bangsamoro citizens. Through the portal or the online platform, civil servants will be equipped with a tool to simplify access to public services thereby reducing the time, cost, and number of visits (TCV) required for the BARMM citizens to have access to e-Services.

Anent this, we are informing concerned employees to participate in the Training of Trainers for the Business Permit, Zonal Clearance and Building Permit e-Services, scheduled from April 22 to 27, 2024, in Davao City. Your active involvement in this training is crucial as we prepare to equip our LGUs with the necessary tools and knowledge to effectively implement the LeAPS Program.
