
THE 'IRAC' MODEL FOR ADDRESSING A LEGAL PROBLEM

- State the key principles from case law, or the relevant sections of the Corporations Act (bullet points)
- 'The relevant law which applies to this scenario is...'

APPLICATION and analysis of the law to the facts in the scenario:

- Spend most of your time here!
- Do <u>not</u> merely repeat the facts! Instead, identify <u>relevant facts</u> for each character, showing who is involved, who has suffered, and what the problem is (different people may be doing different things that are wrong);
- Apply the law from applicable statute and apply legal principles from key cases;
- Explain the law do not just state it.
 Marks are given for problem solution and analysis.
- 'This legal principle/ rule states that... and the facts state that...'

State a brief CONCLUSION of the consequences of your analysis:

- Make a judgment call: state who is liable, and for what?
- A one sentence conclusion/ bullet point for each character only
 - 'Therefore, the likely outcome for X is that...'
