Candidates who did 'A' Level before 2013 should have 15 and 14 points for male and female applicants respectively.
- iii) Diploma Holders: Must possess at least a 2nd Class or Credit Diploma from a recognised institution. Certified Copies of Diploma Transcripts (No Provisional Results) from the Awarding Institutions must be attached to the Application Forms.
- iii) Mature Age Applicants: Must have passed the Makerere University Mature Age Entry Examination (for Bachelor of Laws) for either October, 2021 or December, 2022.
